WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Guru Nanak College of Education, Near Nehru Stadium, Bidar-585401, Karnataka run by Sri Nanak Jhira Saheb Foundation, Bidar, Karnataka vide order No. F.SRO/NCTE/B.Ed./2004-2005/8875 dated 30.11.2004 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations vide a notarized affidavit dated 20.01.2015. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, a Show Cause Notice was issued to the institution on 24.04.2019. The institution has submitted reply on 22.01.2021.

4. AND WHEREAS, the SRC in its 406th meeting held on 19th January 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 03.02.2022. The institution has submitted a reply on 17.02.2022.

5. AND WHEREAS, the SRC in its 409th Meeting held on 29TH - 30TH March, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Guru Nanak College of Education, Survey No. 19-A, Teacher Colony, Manhalli Road, Bidar District-585401, Karnataka for B.Ed. programme for 1 basic unit of 50 students".

6. NOW THEREFORE, this order is issued permitting the institution i.e., Guru Nanak College of Education, Survey No. 19-A, Teacher Colony, Manhalli Road, Bidar District-585401, Karnataka run by Sri Nanak Jhira Saheb Foundation, Bidar, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution, **Guru Nanak College of Education, Near Nehru Stadium, Bidar - 585401, Karnataka** has by affidavit consented to come under New Regulations and sought for one unit in B.Ed which require additional facilities.

3. AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 30.11.2004.

4. AND WHEREAS, the SRC has decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely,

- i. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
- ii. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution does not fulfill required norms of infrastructure recognition will be withdrawn.

5. NOW THEREFORE, in the light of the above and in terms of Section.14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Guru Nanak College of Education, Near Nehru Stadium, Bidar - 585401; Karnataka for conducting B.Ed programme of two years duration with an annual intake of 50 students one basic unit from the academic session 2015-16 subject to fulfilment of the conditions mentioned at 4.(i) and 4.(ii) herein before 31st July, 2015.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;



Now therefore, in exercise of the powers vested under Section 14(3) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Guru Nanak College of Education, Near Nehru Stadium, Bidar-585401, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students subject to fulfillment of the following:

- a. The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.





- (5) The management should start the institution only after obtaining recognition from the National Council for Teacher Education under Section 14 of the NCTE Act, 1993.
