


### RESOLUTION



The following Board of Management members are elected in the meeting.



**2. ADDRESS OF THE SOCIETY :**




**3. AREA OF OPERATION :**

**1. EXPLANATION**

- a) Society Means : Any aims and objectives (mentioned in the Memorandum of Society) to be established. Run, maintained protect etc; by the Society.
- b) General Body Means :The General Body comprising of all the valid members of all categories under the rules and regulations of the Society.
- c) Board of Management :-The Board of Management constituted by the General Body of the Society and -see all the work of the Society.
- d) Members Means :-A person who is alumni of College and full-fill all the conditions of the society and enrolled as a member of the Alumni Society.

**2. MEMBERSHIP:-**

- 1) Membership of the Society shall be opened to all alumni of the college who subscribes to the aims & objectives of the Society to abide these rules thereof.
- 2) Every alumni who want to become member should strictly abide by the constitution, rules and regulations of the Society.
- 3) Every alumni who is a member has the right to participate in all the activities of the Society in accordance with the constitution.
- 4) Every alumni who want to become member should have sound mind and good moral character.
- 5) Every alumni who want to become Member of the Society has to contribute Rs. 500/- (Five hundred Rupees only)- as membership fee at the time of registration in the Society.


- 6) The admission to the society as a member can be done on producing an application along with the prescribed fees of Rs 500/- (Five hundred Rupees only) and recommended by any two members of the management committee of the Society . It shall be within the power of the management committee of the Society to accept or reject any membership without assigning reasons by majority of the present members of the society.
- 7) The membership shall be ceased or can-celled in case of death or involvement in any crime or illegal or anti social activities or failed to pay membership fees .
- 8) A member can retire voluntarily from the membership by giving a written resignation to the secretary.
- 9) Membership fee may be revised as determined by the general body from time to time.

### 3. CONSTITUTION OF THE GENERAL BODY:

- a) The general body of ALUMNI CELL SOCIETY", GURU NANAK COLLEGE OF EDUCATION ALUMNI SOCIETY, BIDAR. Shall consist of all members.
- b) The general body shall meet once in a year preferably in the month of June/July every year transacting the following items.
- c) To consider and adopt the report of the activities of the ALUMNI CELL SOCIETY", GURU NANAK COLLEGE OF EDUCATION ALUMNI SOCIETY, BIDAR during the past year / coming year and to audit accounts balance sheet relating to the year under report.
- d) To elect the office bearers of the managing committee once in three years.
- e) To review the progress and to adopt resolution thereon amendment of rules and regulations.
- f) It is the policy making body of Society and given approval & ratification for the projects. Annual plans & reports. Budgets & expenditures of the society.
- g) The general body of the society reserves the right to constitute from general body, Project Management committee & other committee as required to discharge, the objectives of the Society.
- h) Only the General body has powers to dissolve the Society and bring in any amendments In By-laws of the Society with the approval of majority of present members of General Body.

#### 4.CONSTITUTION OF THE BOARD OF MANAGEMENT :

The management of all matters connected with the "ALUMNI CELL SOCIETY", GURU NANAK COLLEGE OF EDUCATION ALUMNI SOCIETY, Bidar shall be the responsibility of Board of Management. The Board of Management shall consist of the President, Vice President, Secretary, Treasurer & other members' total (08).

- a) The Board of Management of ALUMNI CELL SOCIETY", GURU NANAK COLLEGE OF EDUCATION ALUMNI SOCIETY, Bidar " Shall have all the powers to implement the aim and objectives of the Society, including momentary transactions and administration,
- b) The term of office of the Board of Management of ALUMNI CELL SOCIETY", GURU NANAK COLLEGE OF EDUCATION ALUMNI SOCIETY, BIDAR" Shall be 3 years


#### 5. MEETING

- a) The Board of Management of ALUMNI CELL SOCIETY", GURU NANAK COLLEGE OF EDUCATION ALUMNI SOCIETY, BIDAR Shall meet at least once in a three months or more if-necessary as per requirement.
- b) At least 07 days notice together with the agenda shall be given to the members of the managing committee meeting.
- c) The quorum for a meeting shall be majority of the total member of General Body.
- d) Accidental omission to give notice of a meeting or non - receipt of a notice of meeting by any person entitled to receive notice shall not invalidate the proceeding of that meeting.
- e) The President/Vice President shall chair the Annual General Body meeting. In their absence chairperson should be elected from the members present in the meeting, for chairing the meeting.

2. The treasurer shall be responsible for maintenance of account like cash book ledger receipt book, payment voucher and all documentary records pertaining to the receipt and payment of the society including the bank pass book & cheque book of the society and preparation of annual budget estimates / account & he/she shall be in charge of all collected funds and cash balance, shall arrange to get the account of the society audited manually as approved by the Board of Management.

#### 7. FINANCIAL ASSISTANCE :-

The financial resources for the objectives and the activities of the Society shall through:-

- Donation from members, public etc.
- Loan and Grants from Members, Govt. Banks and any other authorities.
- Cultural activities/programs etc.
- The Association is supported financially, in part, by membership fee paid by the members.

All the property and funds of the Society shall belong to the Society collectively. No Individual members shall have any property and funds right over them.

#### 8. BANK ACCOUNTS:-

All the bank accounts in the name of the society shall be operated through cheque, draft etc. With the joint/signature of the President, & Secretary of the society

#### 9. AUDIT :-

The Accounts of the Society shall be audited by a Auditor in every year and the audit report should be approved by the General Body. All the audit rectification shall brought to the notice of the Members with in 15 days of the audit rectification.

#### 10. ANNUAL RETURNS :-


Annual returns and list of the Board of Management members with their particulars be submitted every year with the Registrar of Societies, Bidar in accordance with section-13 of the KSR Act. 1960.

#### 11. ELECTION OF THE SOCIETY

- The vote would be cast by secret Ballot method.
- The election of the Office bearers will be held in supervision of nominated person/persons nominated by the Board of Management.

#### 12. AMENDMENT:-

- The majority of the present member of General Body can amend the constitution of the Society in meeting.
- The amendment to the Society shall be made in accordance with section-9 and 10 of the KSR Act. 1960. Such amendments should be approved by the registrar of societies, Bidar before effecting it.

**16. FUNDS INVESTMENTS:-**

The funds of the society shall be invested in modes specified under the provisions of section 13(1) (d) read with section 13(5) of Income tax Act. 1961.

**17. WORKING HOURS OF THE SOCIETY :-**

The working hours of the Society shall be from 09:00 am to 1:00 pm and from 2:00 pm to 5:00 pm.
