The Scope of collaboration on Academic and Research activities in this Memorandum of Understanding includes the following categories:


- First Aid Training.

## Commencement, renewal, termination and amendment



If either partner institution wishes to terminate the MOU at the end of the five-year period, it must notify the other institution not less than six months prior to the expiry of the MOU.



This MOU or its renewal and the actions taken under it may be reviewed at any time.


Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.


## Annexure I

### Rules governing Academic Collaboration between two institutions

1. Each institution will nominate one of its members as its representative in-charge of the cooperative program. Individual programs of work under this Memorandum will be jointly planned and conducted by the nominees of both parties.
2. Progress of the work of any individual program will be reviewed and approved by designated authorities of both parties.
3. The final approval of any project will depend on the availability of guaranteed support.
4. Participants will be subjected to the rules and regulations of the host institution, in addition to specific rules and regulations, if any.
5. The host institution will evaluate the nomination and determine their suitability for selection under any Programme.
6. The host institution will inform the home institution of any technical or other problems that may arise during the period of student's residence in the host institution. The host institution will take appropriate action under its established policy and procedures, in consultation with the home institution to deal with such problems.
7. The parent institution will be responsible for the financial budget if any for their respective participants if any.
8. The prospective students will be allowed to undergo First Aid training.
9. To organise awareness programs for the community on disease prevention, spread, screening and control strategies.
10. Organise and conduct short term training programs on Cancer prevention and diagnosis, Tobacco cessation, de-addiction, screening and rehabilitation, awareness etc.
